
#### **OPERATING INSTRUCTIONS**

- 1. Turn the unit upside down and remove the battery cover.
- 2. Install two new AA batteries in the battery compartment in the correct orientation, noting the polarity of the
- Open the foil wrapper containing the new repellent pad. Using the wrapper to hold the repellent pad, insert the repellent pad into the repellent holder inside the device.
- 4. Replace the battery cover.
- To turn the device on, place the unit upright and press the power button. The LED inside the device will illuminate to indicate that the device is operational.
- 6. To turn the device off, press the power button. The LED will turn off to indicate that the device is off.

#### **BATTERY AND REPELLENT PAD REPLACEMENT**

- 1. After 6 hours of operation, the repellent pad should be replaced to ensure optimal device operation.
  - a. Turn the device upside down and remove the battery cover.
  - b. Remove the installed repellent pad and discard.
  - c. Open the foil wrapper containing the new repellent pad. Using the wrapper to hold the repellent pad, insert the repellent pad into the repellent holder inside the device.
  - d. Replace the battery cover.
- If the LED no longer illuminates when the power button is pressed, the batteries are depleted and need to be replaced.
  - a. Turn the device upside down and remove the battery cover.
  - b. Remove the installed batteries and discard in accordance with local regulations.
  - c. Install two new AA batteries in the battery compartment in the correct orientation, noting the polarity of the batteries.
  - d. Replace the battery cover.

Problem:	Possible cause:	Correction:
LED does not illuminate and fan does not spin.	Installed AA batteries are depleted.     AA batteries are installed incorrectly.	Install new AA batteries in the device.     Ensure AA batteries are installed in the correct orientation, noting the polarity of the batteries.
Fan does not rotate.	Fan blades are obstructed or blocked by debris.	Remove batteries from the device.     Remove any debris causing the fan blockage with a vacuum or blower.
Repellent pad scent is no longer present.	Installed repellent pad is depleted.	Install a new repellent pad in the device every 6 hours for optimal operation.
