- 2. To disconnect, remove plug from outlet.
- 3. To reduce the risk of injury from moving parts or electric shock, always disconnect plug before servicing or cleanina
- Do not position the unit near heat, aas, oil or other flammable materials. 4.
- Place out of reach from children. 5.
- To reduce the risk of electrical shock, do not put appliance in water or other liquid 6.

- Unpack unit. Save carton for storage (if needed).
- The unit will turn on automatically when plugged in. For best catch results, leave the trap on and running, 24/7. 2. 3. Catch rate activity will be higher at night. For best catch results it is recommended to keep the unit away from
- competing light sources. This unit is for indoor, household and commercial use only. 4.
- 5. Remove liner from StickvTech™ Glue Card and place in base of retaining cage (Glue side up).


CLEANING

Frequent cleaning will prolong the life of the unit, ensure fire prevention and provide for more efficient operation.

- 1. Be sure to clean the unit at least once per month.
- Unplug the unit. CAUTION: There may be insects still alive when opening the trap. 2.
- For monthly cleaning, remove the catch basket by turning it to the left. 3. Remove any buildup from the inside of the catch basket and fan with a brush.
- When replacing the catch basket DO NOT press/push against the screen windows. 4
- 5 Clean prior to storage.
- Replace StickyTech™ Glue Cards every 30 Days, or as needed. 6.
- Remove liner from new StickvTech™ Glue Card to expose alue and place Glue Card (Glue side up) in bottom 7. of catch basket.

HOW THE DYNATRAP® INSECT TRAP WORKS

Flying insects are attracted to the DynaTrap® by dual-wavelength UV-LED bulbs and CO2 that is generated by the photocatalysis between the UV light and special TiO2 coating. The whisper-quiet fan then pulls the insects into the ultra-fine mesh catch basket, trapping them on the StickyTech™ Glue Card, where they are unable to escape. The catch basket can be removed, allowing the contents to be periodically emptied into the trash. Monitor the insects trapped in the catch basket and replace with a fresh StickvTech™ Glue Card every 30 days, or as needed.
